Special Collections The Library's special collections were primarily acquired through contributions since the Library's inception. Special collections is defined as any current or future special/permanent/historical collection item, including but not limited to rare books, manuscripts, archival holdings, and photographs housed in the Oliver Room or other secure spaces. Special collection items are not recognized as an asset on the statements of financial position. Purchases of new special collection items (none in 2023 and 2022) would be recorded as a decrease in net assets without donor restrictions in the year the items were acquired, or as a decrease to net assets with donor restrictions if the assets used to purchase collections were restricted by donors.

All special collections are subject to appropriate stewardship measures (catalogued, preserved, secured, and cared for as appropriate, finding aids created, and activities verifying their existence and assessing their condition).

The Library's policy is that proceeds from the sale of special collection items, or insurance recoveries on the loss of special collection items would be used to purchase suitable new special collection items or used for direct care of the special collection. Direct care for the Library's special collections is defined as expenses to enhance the life, usefulness and quality of the item, that are based on an institutional plan for the special collection. In 2023, 1,432,005 visits were made to all CLP locations. Circulation of physical materials totaled 2,341,271 and circulation of eResources continued to grow dramatically. CLP circulation of eResources totaled 1,131,647, an increase of 12.7% over 2022. Total circulation of eResources countywide rose 11% to 3,610,946 from 3,249,136 in 2022. Over 2.5 million items were delivered through CLP Shipping to libraries in Allegheny County. These statistics indicate that our community values and depends on the Library and the many resources it offers to help meet their diverse needs.

Library service highlights of 2023 included:

Allegheny County Law Library CLP partnered with Allegheny County to assume responsibility and operations of the Allegheny County Law Library (ACLL) in July 2023. This collaboration between CLP and Allegheny County has provided a smooth transition of operations with continued access to resources and services to the public and legal professionals.

Best Books for Babies/Diaper Distribution CLP and the Western PA Diaper Bank hosted a drive-up diaper and Best Books for Babies book bundle distribution event at CLP-Hill District. 400 bundles of board

books along with more than 40,000 diapers were distributed to families.

CardFest CLP is committed to providing all Pittsburgh Public Schools (PPS) scholars with a library card. In 2023, CLP and PPS expanded the CardFest program by adding three more schools, including Faison K-5, Miller PreK-5, and Westinghouse 6-12. These new schools joined the 2022-2023 schools, Beechwood PreK-5 and UPrep/Milliones 6-12, in CardFest. All students received a new library card and were visited at their schools by CLP to learn what they can do with their card. The plan is to reach all PPS scholars in Fall 2024.

Community Collections CLP continued depositing Community Collections and making visits to various sites across Pittsburgh to increase community access to library materials for those who may not be able to visit a library or access resources online.

Pittsburgh Ready Pittsburgh Ready strengthened connections between CLP and the community by offering childcare providers access to a broad range of supportive library services. CLP provided early literacy resources and support to under-resourced family and group home childcare providers.

Pittsburgh Public School Partnership In addition the CardFest program, CLP continued to serve Pittsburgh Public Schools' nine Community Schools through relationship building and dedicated service. CLP staff were able to connect school staff, students and families to library resources that help address each school's unique needs. CLP staff attended Summer BOOST Kick Off Nights and sent Summer Reading bags and

book logs to each regional camp location for the students. CLP served as an official partner in Pittsburgh Public School's "Take a Father to School Day" with staff visiting select schools to share Library information and sign kids and dads up for library cards.

Summer Reading 2023 Summer Reading focused on the importance of avoiding the "Summer Slide" and encouraged people of all ages to read five books. CLP partnered with the August Wilson African American Cultural Center (AWAACC) and Pittsburgh CLO as the first official "Summer Program Partners" for the Summer Reading Program. Partners received summer outreach visits, curated booklists for their camp groups, and were invited to participate in Summer Reading Extravaganza.

B. LAMP: Library of Accessible Media for Pennsylvanians, a network library of the Library of Congress National Library Service for the Blind and Physically Handicapped (NLS LBPH), served more than 14,700 individuals across the Commonwealth of Pennsylvania during the 2022-23 fiscal year, with the circulation of almost 1.1 million items. Staff answered reference questions, promoted accessible technology, discussed the latest bestsellers and favorite authors, and suggested new titles patrons might enjoy. The print and electronic collections offered by LAMP include large print books, audio-described DVDs, audiobooks and magazines, physical braille books, and downloadable audio and braille services such as books and magazines offered through NLS LBPH.
